All of our dogs are housed in the kennel. Dogs receive daily cleaning, feeding twice a day and animal care. Our veterinarian and support staff conduct daily rounds to make sure all the animals are safe and healthy.

Our Enrichment Program is designed to improve each animal's quality of life while in our care. By providing our animals with mentally stimulating activities, toys and plenty of exercise and socialization; we're stimulating their senses and reducing their stress levels. Every animal available for adoption has been examined by our Veterinarian, microchipped, given necessary vaccinations and has been spayed or neutered. Treatment for fleas and parasites is provided. We also test for common diseases such as heartworm, feline leukemia and FIV. Our veterinarian and vet techs on staff are very busy!

Although Lake Humane Society takes in thousands of animals every year, there are never enough warm cages and loving hands to care for all the animals in need. Many times we take animals in that require a little extra space, time, attention, and love. Whether it's a litter of young kittens too small to be vaccinated or a dog in need of recovery time after an extensive surgery, Lake Humane Society couldn't provide them the much needed care without the help of our Foster Program.
