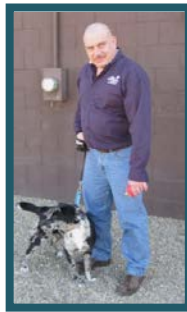
Please take a look at our upcoming events schedule and make arrangements to attend. We look forward to seeing everyone and making 2011 another wonderful year with many more lives saved.

Our staff would like to send a warm and deep hearted thanks to all the volunteers and donors that make Lake Humane Society possible.

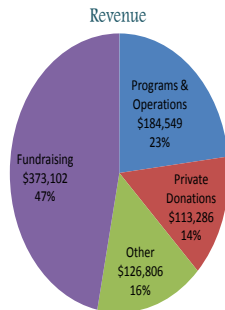
